



# **E/LEAD:** A Personal Approach to Student Success

How can ETHS prepare ALL students for a bright future while still in high school? A new program aims to ensure that no student is overlooked.



ast year, with the help of generous seed funding from a donor passionate about access to opportunity, the E/LEAD program became a reality. E/LEAD (Evanston/ Leadership Academy) is a four-year, cohort-based "school within a school" for students in the academic middle who might otherwise graduate without being connected to a particular career pathway.

"This program represents our commitment to ensuring every student finds their path and develops meaningful connections during their high school years," said Theresa Collins, Director of Student Academic Leadership Programs, who returned to ETHS specifically to develop and implement this vision.`

The program follows a thoughtful progression throughout students' four years that Collins describes as "Expose, Engage, Experience." Exposure to academics and careers in co-hort only classes, engagement through job shadowing opportunities and speakers, and experience in workplace-based opportunities in the Evanston community. Students also have the same advisor all four years—an anchor connection in the building guiding them throughout their high school experience.

"The advisory space is where students will really focus their interests and develop their cohort community," said Collins. "Through the lenses of Leadership and Identity, we want to develop the sensibility around experiences that broaden who they are and who they want to be—to round them out academically, socially, experientially."

The E/LEAD program represents a strategic investment in ETHS students who might otherwise miss crucial opportunities for career exploration and personal growth. By providing structured guidance, meaningful experiences, and consistent mentorship, E/LEAD helps students discover their unique talents and interests before graduation. As this innovative program continues to develop, your support of the ETHS Foundation ensures that every student-regardless of their academic standing—has the chance to find their path and build a base for future success. # ALUMNI HALL: Honoring Our History, Supporting Current & Future Students



his year, the newly renovated Alumni Hall opened its doors welcoming students, faculty and community members to a space built for innovation and connection. What was once a large nondescript multi-purpose room has been reimagined as a collegeinspired learning environment featuring modern technology and architecture. This dynamic space also stands as

a testament to the rich Wildkit experience. Display cases throughout the hall showcase artifacts and historical items that honor the legacy of excellence at ETHS.

Among the room's notable features is a striking painting by Tacoumba T. Aiken '70, commissioned by the class of 1970. Aiken, a 2022 Guggenheim Fellow, is a renowned painter and public artist whose "superlative realism" style brings vibrant energy to the space, inspiring current students through the accomplishments of those who came before them.

From its inception, Alumni Hall was conceptualized with inclusivity at its core. For senior Olivia Ohlson, Alumni Hall has quickly become an integral part of her ETHS experience. "I've used Alumni Hall in a variety of ways," she explains. "My English class watched a movie there for our *Philosophy Through Film* unit. We regularly meet there for the Black Summit Planning Committee, the Varsity Club/Student-Athlete Advisory Committee, the Community Service Club, and Team ASAP. Together, these clubs serve hundreds of students—and when you include the many classes that use the space, that number grows exponentially."

Ohlson particularly appreciates the space's modern amenities: "We can use the large screen to view videos and Zoom in presenters from all over the country. The modular, adaptable furniture allows the room to be set up for boardroom-style meetings, small group tables, large group discussions, sharing circles, and more."

Alumni Hall's impact extends beyond practical considerations. "Renovated spaces like this show students that we deserve modern, functional environments, and they make us more motivated to learn and get involved," Ohlson explains. "They serve as points of pride for students, faculty and donors and represent a vision of what ETHS can look like in the future."


